32	2/16/2010	We assume that more than one specialty second-tier subcontractor can be submitted for the same work scope. Is this assumption correct?	"Second-tier subcontractor" means a firm or individual contracting with the Trade Subcontractor, who in turn contracts with Webcor/Obayashi. Second-tier subcontractors do not need to respond to the RFQ, whether they are SBEs or non-SBEs.
